Prof. Rear Admiral (Ret.) Shaul Chorev

Head of Haifa Maritime Policy & Strategy Research Center (HMS), Haifa Israel. A professor at the University of Haifa Political Science School. Prof. Chorev is the former Head of the Israel Atomic Energy Commission. He has held many important positions in the Israeli security forces including Assistant to the Minister of Defense for Nuclear, Biological and Chemical Defense; Deputy Chief of Naval Operations; Commanding Officer of the Haifa Naval Base and Commanding Officer of an Israeli Naval Flotilla. Chorev holds a BA in Economics and Political Sciences from Bar Ilan University, MSc. from the United States Naval Postgraduate School and Ph.D. from Bar Ilan University.



Dr. Nicholas A. Ioannides

Holds a PhD in Public International Law from the University of Bristol. He teaches Public International Law and International Humanitarian Law at the University of Cyprus. He was also a Nippon Fellow at the International Tribunal for the Law of the Sea (2017–2018), where he conducted research on the legal framework governing undelimited maritime areas. In 2020, he was awarded the 'Daniel Vignes' Prize by the International Association of the Law of the Sea for his article on hydrocarbon activities in undelimited maritime areas, published in the International and Comparative Law Quarterly (2019). His monograph entitled 'Maritime Claims and Boundary Delimitation: Tensions and Trends in the Eastern Mediterranean Sea' has been published by Routledge.



Dr. Noha Bakr

PhD in inter disciplinary field of International Relations, and International Organizations. She has received a distinguished Alumni award from the American University in Cairo & National Defense University of Washington. Associate Professor the American University in Cairo. Dr Bakr is a Member of the National Council of Human Rights & Member of the Supreme Council of Culture. Her Academic Career is mainly a Political Science associate professor teaching International Organizations & Human Rights & Gender issues. Her Civil Servant experience was being the former, Assistant to the Minister of International Cooperation, in charge of international economic cooperation with Canada and the Americas.
